TERMS AND CONDITIONS

This agreement ("Agreement") sets forth the terms and conditions governing membership in The Ndlovu Club ("Club") operated by African Bush Camps ("Company"). This is a trade-inclusive initiative. For trade terms and conditions, please see point 6. By participating in the Club, members and trade partners agree to abide by these terms.

1. Eligibility & Membership

1.1 Membership is available to clients who have travelled with African Bush Camps for three (3) nights or more within the last four (4) years.

1.2 Membership benefits are granted exclusively to the primary booker ('Member'), whose name appears as the main booker on the reservation.

1.3 The primary booker must remain the main booker to be eligible for benefits under this Agreement.

2. Exclusive Member Benefit

2.1 Members are entitled to a five percent (5%) discount on bookings of three (3) nights or more at African Bush Camps' properties. This 5% can only be used on ABC-owned or managed accommodation. This does not include the Community and Conservation Levy, flights and transfers, or any other extras.

3. Referral Program

3.1 Members may refer new travelers to African Bush Camps.

3.2 If a referred booking of three (3) nights or more is confirmed and paid for, the referring Member ('Referrer') shall receive a credit of five hundred dollars (USD \$500) toward a future trip.

3.3 Each qualifying booking shall entitle the Referrer to one (1) USD \$500 credit.

3.4 Referral Reward Credits may only be applied to bookings of three (3) nights or more at African Bush Camps' properties.

3.5 International Members may accumulate and use up to four (4) Referral Reward Credits at any time, while SADC Members may accumulate and use up to two (2) Referral Reward Credits at any time.

3.6 All Referral Reward Credits shall expire two (2) years from the date of issuance, if not used on a confirmed booking.

4. Referral Advantage for Referees

4.1 The main Booker referred by a Member ('Referee') shall be eligible for a five hundred dollar (USD \$500) credit toward their booking. Note that this applies for new bookings only and cannot be redeemed against an existing booking in our system.

4.2 The Referee must be referred through the Member's referral code or by the full name of the Member as registered with the Club. A Referee can only be referred by one Member. Multiple referrals by different Members for the same Referee will not be accepted.

4.3 The Referral Advantage shall only be applicable to bookings of three (3) nights or more.

4.4 The Referee must be referred through the Member's referral code or by the full name of the Member as registered with the Club. A Referee can only be referred by one Member. Multiple referrals by different Members for the same Referee will not be accepted.

5. General Terms for Club Benefits

5.1 All Club benefits, including the Exclusive Member Benefit, Referral Reward, and Referral Advantage, are only available to guests paying full international or SADC rates.

5.2 These benefits may be used in conjunction with African Bush Camps' Packages but may not be combined with any other discounts.

5.3 The Exclusive Member Benefit may be used together with the Referral Reward, allowing International Members to apply up to four (4) Referral Reward Credits and SADC Members up to two (2) Referral Reward Credits in combination with the Exclusive Member Benefit.

6. Trade Partner Access to Ndlovu Club Benefits

6.1 The Ndlovu Club benefits are accessible through our trade partners. If you previously booked African Bush Camps through a travel agent, you must book through that same channel to redeem your rewards.

6.2 Trade partners shall bear the responsibility for providing all necessary documentation to verify that their clients meet the eligibility criteria set forth in this Agreement.

6.3 Verification shall include confirmation of past travel history with African Bush Camps and compliance with the eligibility requirements stated herein.

6.4 Trade partners must submit all required documentation at the time of booking to secure Club benefits for their clients.

6.5 African Bush Camps reserves the right to validate and approve eligibility before any benefits are granted.

7. General Provisions

7.1 African Bush Camps reserves the right to amend or terminate this Agreement at its sole discretion.

7.2 Any disputes arising under this Agreement shall be governed by the laws of the applicable jurisdiction where African Bush Camps operates.

7.3 Participation in The Ndlovu Club constitutes acceptance of these terms and conditions.
